



Affidavit of Designation - One Time Participation

Pursuant to §§13-208 and 13-309 of the Election Law Article, Annotated Code of Maryland, we, the undersigned, hereby declare that we intend to participate in the following election for this election year. This will not affect the committee's previous election designation and will not be a recurring designation for future elections outside this expressly designated year. The reports due will depend upon the filing of the designation. Only subsequent reports will be required to file after the submission of the designation. The committee is not required to file any retroactive reports. If the political committee subsequently decides to participate in a future election not designated, the political committee shall notify SBE and file all campaign finance reports required for that election.

## Instructions For Filing the Affidavit of Designation

### 1. What is the Affidavit of Designation - One Time Participation?

The Affidavit of Designation - One Time Participation is an affidavit filed by a committee that states that the committee will participate in the election year selected. If you spend or receive any money in connection with the election on the current ballot, then you are participating in the election.

Example of Participation:

- Participation in the Baltimore City Election includes transferring money to a candidate for mayor or making expenditure on behalf of a city council candidate.

This affidavit means you indicate that you are participating in an election not previously designated, therefore you will be required to file all of remaining reports related to that election.

***Important.*** The State Board of Elections sends Pre-Report Notices to all campaign committees that our records indicate owe a Campaign Finance Report. If you receive a Pre-Report Notice, you must either file the report or immediately contact SBE if you believe the notice was sent in error.

### 2. Can I raise or spend money in connection with a past or future election if I designate a particular election?

Yes. The Designation only limits your activity in support of other candidates or ballot issues for the current election. For example, you have designated the Gubernatorial election you can still raise and/or spend money in connection with your 2026 campaign during the off years. That does not count as participating in the Baltimore City election year.

### 3. Will this mean I have to follow this reporting schedule in the future?

No. This is only for this election year only.
