SUBJECT: Waiver of late filing fees standards

Enclosed are the waiver requests, which were submitted by campaign committees that have been assessed late filing fees. The attached Waiver Request Information Page contains an overview of each committee as well as the Administrator's recommendation for Board approval on granting a waiver request.

In the past the Board has considered the following facts in determining whether just cause exists to grant a waiver.

- □ Administrative error of any kind on the part of the Division.
- ☐ The lateness is due to extenuating circumstances, i.e. physical illness or death in the family.
- ☐ The late report is the first late report and allows the committee to close, or contains minimal financial activity.
- □ The fee will cause undue financial hardship, if the liability of the fine is the personal responsibility of the officers.
- Computer problems occurred which made timely filing impossible. However, the filer still must have demonstrated a good faith effort to timely file.

Prior to the meeting please review each waiver request. Note the recommendations that you may disagree with or have questions on that you would like to discuss.

Pursuant to Election Law Article §13-337 (b) (3), the State Administrator has denied six waiver request. No Board action is required on the denials. Late fees collected year to date for Late Fee Waivers are \$47,372.00 Late fees collected for the month of March are \$18,950.00

I am writing to contest the fee assessment for Friends of James Howard. We acknowledge that a \$20.00 fee should be assessed however the \$1000.00 assessment is incorrect.

On November 23, 2022, we received a fee running notice for the 2022 Gubernatorial Post-General election, which was due on November 22, 2022. We missed the filing deadline by one day, and the treasurer of our organization, Mr. Booms, filed the report immediately after receiving noticd on November 23. I approved the report on the same day.

On December 30, 2022, we received another fee running notice. As we had received incorrect fee notices in the past, we did assumed that it was related to the previous notice. Mr. Booms timely submitted the 2023 Annual report, which was due on January 18, 2023, and I approved it on the same day.

We discovered that the report that was submitted on November 23 was credited as the 2023 Annual report, and the December 30 filing was credited as the 2022 Gubernatorial Post-General report.

Please note, there is no material difference between the two reports, as both show that no transactions have taken place. It is further unclear why the system could have accepted or credited a report at the 2023 Annual Report on January 11, 49 days before the period closed. Our errors amount to a single day late, and the associated fee of \$20.00 is appropriate.

Dear Board Members:

New information that assures me that my inability to file reports efficiently was not due to user error, as I had presumed but rather system errors with MD CRIS that continue to persist.

Accordingly, I am updating my request for a waiver. Not being reimbursed the earlier paid \$350 fine would be an unjust ruling given the Maryland SBOE has now confirmed that there were system errors complicating my attempts to file the report timely.

It would additionally be an unjust ruling if the Board required that I pay a \$2000 fine for not filing reports that would have reflected zero expenditures and zero contributions for an election phase to which I had not advanced and in which I did not participate. No harm resulted from this good faith review and interpretation of the rule.

In my earlier submitted waiver request, dated December 30, 2022, I referenced that I was able finally able to file the report due on July 8, on July 21, with assistance from SBOE. The challenges I experienced when attempting to file the report on July 8 were due to persistent SBOE errors, as SBOE later informed me after I had submitted the waiver request dated December 30.

Please note that at all times, the SBOE staff have been first class. Each person with whom I have interacted has been incredibly gracious, kind, well-informed and quickly responsive to my requests for assistance. Without the staff, I would still be trying to figure out why each entry in MD CRIS was getting duplicated. Nor would I have been able to ultimately file the reports work around ongoing system errors.

1. MD CRIS system errors—not user error—were the primary cause of my delay in filing the July 8 report such that I filed it on July 21.

Throughout the 2022 summer of filing reports, I was not able to make MD CRIS tabulation exactly match the spreadsheet totals that I was uploading.

Initially, the errors were small. After triple checking my uploads and confirming the information was correct, the system would still present a slightly different number. Because the differences were relatively small, I continued to move forward. However, when I began preparing the reports in advance of the July 8 deadline, the system reported numbers significantly different from my uploads and internal records.

Because I was solo-parenting my five-year old at the time, with my husband and treasurer both traveling overseas, I delayed filing the report because I did not want to file information in advance of the Primary election that I knew to be wildly incorrect.

After the election, I received assistance from your office to file the report. I learned that the contributions were duplicating themselves after I submitted them to MD CRIS, but at the time SBOE staff did not know why. In July and in August of 2022, your office helped me systematically go back through each report to remove duplicate entries of contributions.

In January 2023, when the office returned my call to discuss how to make the numbers properly align in the closeout report, I learned that MD CRIS itself was duplicating entries due to a system error and that staff had to help ensure that there were not duplicate entries in the submissions of several candidates.

This meant that my ability to efficiently file the July 8 report was not a user error, as I had presumed. Instead, I was not able to overcome the system error. That same system error had affected my two previous reports, such that by the third report there was an uncomfortable distance between my internal records and what MD CRIS was tabulating.

At the time, I believed the fine to be only \$20 per week so I waited to file until I had the bandwidth to figure out the problem. I did correct the problem with help from your staff, but I still believed it to be user error on my end, which it was not. Had the system worked properly when I tried to file my report on July 8, I would have been able to file it timely.

I should not be fined for not being able to file a report efficiently due to system errors. If I had understood there were system errors at the time affecting multiple candidates, I would have requested permission to file paper reports, which I could have done timely.

2. It would be a miscarriage of justice to impose a \$2000 fine for a good faith misinterpretation of a rule, that if properly followed, would have led to October 28 and November 22 reports of zero expenses, zero contributions, and zero activity of any kind for someone not even on the ballot.

I did not file the October 28 and November 22 reports because I believed that, by not having advanced to the primary and having zero expenditures and zero contributions to report, there was nothing I could report in advance of closeout. I understand now that this was an innocent misinterpretation of Section 3.4 of the Campaign Finance Rules, as I explained in my December 30 Waiver Request.

I should not be fined \$2000, however for that misunderstanding. Indeed, it would be a draconian miscarriage of justice if, in my good faith attempt to follow the rules, I were fined for misunderstanding them even though I had zero expenses, zero contributions, and zero activity of any kind. No person, public or agency was even remotely affected my misinterpretation.


My good faith is additionally evidenced by the fact that as soon as I had activity—that is, payment of the last remaining outstanding debt obligation—I immediately reported the activity and filed for closeout of the report, consistent with my interpretation of the rule.

3. Filling challenges continued through January 26, 2023 due to ongoing system errors and because the SBOE guidance originally provided regarding how to address candidate contributions was not effective.

My closeout report continued to show a negative cash balance of \$1626.29. This was the sum of a candidate contribution for \$1188.00 in expenses (disclosed on the August 30 report) and a second candidate contribution on December 11, 2022 to pay an outstanding debt obligation (disclosed on the January 13 closeout report).

SBOE instructed me to make both candidate contributions in-kind contributions, but this did not actually work because the cash balance still showed as negative. At the time that I was trying to update the candidate contributions, I also inadvertently marked bank balances as zero for multiple reports. I was finally able to correct this on an amended report dated January 26, 2023.

For one of the contributions, I should have been able to enter MD CRIS and update the outstanding debt obligation as paid. However, a system error never allowed me to do so. Please see the screenshot below: The debt obligation was in fact taken in a past Filing Period to the State but the system still would not allow me to amend the outstanding obligation as paid. The dialogue box refused to allow me to proceed.



In the January 26 amended report, I was finally able to figure out a different way to show the debt as paid, but I was not able to use the MD CRIS feature that is for this situation. The feature still is not functioning as far as I know.

4. The Board is asking for immediate payment of the \$2000.00 fine, even though I have submitted a waiver request that the SBOE said could not be heard before February 2023.

Finally, I submitted a request for a Waiver on December 30, 2022. SBOE staff informed me that due to a backlog, my request for a Waiver could not be heard at the January 2023 meeting. Instead, it would not be heard until February 2023. However, I received a notice dated January 12, 2022, in response to my request for a closeout, that if I did not pay the \$2000 within 30 days, then SBOE would impose additional monetary penalties against me.

This does not make sense. I filed the closeout report and the request for a waiver together. If the Board is not able to hear the request for the waiver within 30 days, then payment should be delayed until after the Board can hear the Waiver request.

It would not make sense to pay \$2000 or be assessed more fines—on the basis of two reports with zero expenses, zero contributions, and zero activity for someone not on the ballot. This is especially true given my good faith attempt to follow Section 3.4 of the Campaign Finance Rules as written and consistent communications with SBOE throughout filing reports. The imposition of such a penalty would deter the very best people we need in office from running.

By virtue of this letter I am asking for an extension to pay the \$2000.00 until the Board has had an opportunity to consider the waiver request.

I have since figured out how to work around the system errors so that all the numbers align with my own internal records, which have at all times been properly maintained. I have addressed the problems identified on the notice dated January 12, 2023, with the exception of the fine.

5. For the very best people to run for office, especially representing Baltimore City, we need the technology to work fairly and efficiently.

We need more great people representing the great city of Baltimore at the State level. For that to happen, the systems and technology need to be inviting and efficient to use. Even if the systems are not the most user friendly, they still need to work.

In my case, the systems did not work. There are still features that don't work that I had to work around to file my amended closeout report on January 26, 2022.

I apologize for having interpreted Section 3.4 in such a way that led me to believe there was nothing I should file in the way of a report until I paid the last remaining debt obligation. I hope that the Board Members—Chairman Voelp, Mr. Willliams, Mr. Miller, Mr. Summer, and Ms. Woodward—will extend grace based on these detailed circumstances.

Additionally, if there is anything I can do to volunteer or otherwise help contribute to a working system, to help other candidates understand the rules, or even to boost female participation—especially among working moms—in the affairs and activities of the State Board of Elections, I would be very glad to do so.

| As the candidate, I have been forwarding communications from the SBE to the campaign treasurer, Xuan Musulin. Although she can review them directly from email, I have made a habit of forwarding them to assure that they come to her attention. Until just recently I was unaware that campaign fund reports due on 10/28/22 and 11/22/22 had not been filed timely. When Xuan advised me of same, I inquired as to why they had not been filed, but have not gotten a specific response. Knowing Xuan from daily contact in our workplace and having seen what she has been going through the last several months, I am reasonably confident as to what occurred. Xuan is separated from her husband who contributes very little to support the family that includes an 18-year-old daughter and a 15-year-old son who are emotionally needy to the point that they fabricate health crises and threaten to harm themselves. As you can imagine, this requires an incredible amount of Xuan's time as she works with school officials, social workers, medical personnel, and others following each incident. Xuan's third child is five years old and has Down's syndrome that also requires major time commitments from her. And, Xuan is responsible for her 88-year-old father who has multiple medical issues that require her daily attention. Given those circumstances, I cannot fault her. Until November 26 when she died, I was the Court-appointed guardian and on-site caregiver for a friend of 40+ years with dementia. Since her roots are in Missouri, there has been a great deal to do to get some of her affairs in order. On January 20, shortly after finding out about the failure to timely file the required SBE reports, I contracted COVID for the first time. Although I thought I had recovered, I ended up in Holy Cross Hospital with respiratory issues. I tried to call the SBE from the hospital related to a 'show cause' order, but there was no room on the voice mail to leave a message. The Board should consider the following factors in determining whether just cause exists to grant a waiver.

- 1. Administrative error of any kind on the part of the Division.
- 2. The lateness is due to extenuating circumstances, i.e. physical illness or death in the family; or
- 3. Computer problems occurred which made timely filing impossible. However, the filer still must have demonstrated a good faith effort to timely file.

Prior to the meeting please review each waiver request. Note the recommendations that you may disagree with or have questions on that you would like to discuss.

§ 14-107(c) Late Filing Fees

- (1) As provided in this subsection, the State Board may impose fees for late filing of:
 - (i) a statement required under § 14–104 of this title; or
 - (ii) an amended statement required under subsection (b) of this section.
- (2) The State Board may impose late filing fees in the same amounts and in the same manner as provided under § 13–331(a) and (b) of this article for late filing of campaign finance reports.
- (3) Late filing fees imposed under this subsection shall be distributed to the Fair Campaign Financing Fund.

Pursuant to COMAR 33.20.07.01C, the State Administrator has denied zero late fee waiver request. No Board action is required on the denials.
